Subject: Report on the Quality Assessment Review of the Investigative Operations of the Office of Inspector General for the Export-Import Bank of the United States Dear Mr. AcCarthy:

We have reviewed the system of internal safeguards and management procedures for the investigative operations of the Office of Inspector General for the Export-Import Bank of the United States in effect for the period ending June 30, 2017. Our review was conducted in conformity with the *Quality Standards for Investigations* and the *Quality Assessment Review Guidelines* established by the Council of the Inspectors General on Integrity and Efficiency (CIGIE) and the Attorney General's *Guidelines for Office of Inspectors General with Statutory Law Enforcement Authority*, as applicable.

We conducted our review at your headquarters office in Washington, DC. We reviewed compliance with your office's system of internal policies and procedures to the extent we considered appropriate. Additionally, we sampled 21 case files for investigations closed during the previous 18-month period.

In performing our review, we considered the prerequisites of section 6(e) of the Inspector General Act of 1978, as amended (IG Act), and section 812 of the Homeland Security Act of 2002 (Pub. L. 107-296). Those documents authorize law enforcement powers for eligible personnel of each of the various offices of presidentially appointed Inspectors General. Those powers may be exercised only for activities authorized by the IG Act, other statutes, or as expressly authorized by the Attorney General.

In our opinion, the system of internal safeguards and management procedures for the investigative function of the Office of Inspector General for the Export-Import Bank of the United States in effect for the period ending June 30, 2017, is in compliance with the quality

standards established by CIGIE and the applicable Attorney General guidelines. These safeguards and procedures provide reasonable assurance of conforming to professional standards in the planning, execution, and reporting of your investigations.

Dear Mr. McCarthy:

This is a supplement to our *Report on the Quality Assessment Review of the Investigative Operations of the Office of Inspector General for the Export-Import Bank of the United States*, dated August 2017.

In addition to reporting a rating of *compliant*, the peer review team identified a best practice that we found to be a notable positive attribute of your investigative operations. Specifically, your Special Agents have issued 968 administrative subpoenas since 2009, which is, on average, more than 120 subpoenas per year. During our assessment review, we learned that your office completes and approves most administrative subpoenas in 1–2 days. Your streamlined and expeditious process is to be commended and should serve as an example to other Offices of Inspector General as a means to get needed information in an efficient and timely manner.
